ARE YOU A SUBURBAN RENTER IN COOK COUNTY? YOU HAVE NEW RIGHTS!



The **Cook County Residential Tenant Landlord Ordinance (RTLO)** gives rights and protections to tenants in the Cook County suburbs (outside of Evanston and Mount Prospect, which have their own tenant-landlord ordinances).

Under the RTLO, as of **January 28, 2021**, it is illegal for your landlord to lock you out.

WHAT IS A LOCKOUT?	
Your landlord can NOT:	
Change, remove, or add locksRemove or block doors or windows	Remove your appliances & fixtures
Cut off utility services like electricity, gas, heat, & water	Remove your personal property
Threats & violence against you or your property are also illegal.	

WHAT CAN YOU DO IF YOU ARE LOCKED OUT?

• Call your local police department or 911

Make sure you have your landlord's name & phone number and show proof you live there (lease, rent receipts, ID, bills).

What you might say: Hi, my name is ____. On [DATE/TIME], my landlord illegally locked me out of [ADDRESS] by [EXPLAIN WHAT HAPPENED]. Under the Cook County Residential Tenant Landlord Ordinance, no landlord can evict a tenant without a court order. Please tell my landlord that his/her conduct is illegal and help me get back into my home.

- Call your local Building Department or township
- Call an attorney or housing advocate

WHAT ARE YOUR LEGAL RIGHTS?

You can sue your landlord to get into your unit and get 2 months rent.
