

Mission

 The Lived Experience Advisory Council (LEAC) is a group composed of individuals who have personally experienced homelessness or housing instability. LEAC members use their lived experience to inform and guide policy decisions, program development, and service delivery within homelessness response systems. In Suburban Cook County, the voice of lived experience is intentionally centered through LEAC's active involvement in decision-making bodies, such as the Continuum of Care (CoC) Board and working groups. LEAC members provide critical insights that help shape more equitable and effective strategies for preventing and ending homelessness, ensuring that services are rooted in dignity, accessibility, and real-world understanding. Their leadership ensures that those most affected by homelessness have a direct and meaningful role in shaping the systems meant to serve them.

Launched in September 2022

Guiding Principles: Persons with lived experience are experts and should be valued, supported, and respected. They are not consulted as an afterthought but at all stages of policy and practice in the CoC.

Committee Composition: Individuals with lived expertise who are supported by members from CoC funded service agencies to provide support

Training: Members are provided onboarding training and mentors provide ongoing support if and when needed for members to effectively engage during each meeting

Compensation: Currently \$17 per hour based upon National Low Income Housing Coalition "housing wage" – currently provided via Walmart gift card

Lived Expertise at

- The Lived Experts OFK Committee is charged with:
 - Informing strategic planning and initiative work
 - Reviewing all Continuum of Care policies
 - Advancing projects that grow community knowledge and awareness of homelessness
- Committee members are also tied into local, state, and national advocacy efforts



Moving Forward

- Through community-wide initiatives, Home for All has identified peers as a key component of success
- The CoC is utilizing State pilot funding to employ additional peer supports to supplement existing grant-funded capacity
- These individuals will work in partnership with CoC-funded service agencies to support individuals and families as they move through the stages from homelessness to long-term housing stability
