Latest Budget Updates

- The federal government is in a shutdown since the beginning of the new fiscal year, FY 2026, on October 1.
- A Republican drafted CR passed the House and has failed in the Senate numerous times.
- The CR that Democrats introduced and was voted on in the Senate failed, included numerous important provisions, including:
 - Reverses Medicaid cuts that passed earlier this year in the reconciliation bill.
 - Requires that HUD renew all existing Continuum of Care grants for homeless services expiring during calendar year 2026 for one 12-month period.

Senate and House Budget Proposals

- On July 24, the Senate Approps committee approved their FY26 THUD budget proposal with bipartisan support.
- Overall, the bill provides \$73.3 billion for HUD, a modest increase.
- Senate funding level is much more than the \$67.8 billion allocated to HUD in the House's spending bill and the 44% cut to HUD proposed by the Trump administration.
- The Senate bill rejects harmful and misguided policy proposals by the Trump administration and largely preserves funding for programs that were severely cut or eliminated by the Trump administration and/or the House, including housing counseling, fair housing, HOME and others.

Language in the FY25 Continuing Resolution (CR) provides the HUD Secretary the authority to "repurpose funds made available under" the Continuum of Care (CoC) Builds program "to provide additional amounts for the CoC program"

[&]quot;The Trump Administration's FY26 budget request provides \$10 million, "available until expended, for noncompetitive grants to recipients that received a Tribal HUD-VASH grant in prior years," and transfers control of the VASH program from HUD to the Department of Veterans Affairs for the creation of a new "Bridging Rental Assistance for Veteran Empowerment" (BRAVE) program, funded at \$1.1 billion. The House FY26 budget would fund the BRAVE program at \$970 million in its FY26 Military Construction & Veteran Affairs spending bill.

Issues in Different Housing Sectors

Homelessness

- President Trump's July 24 Executive Order "Ending Crime and Disorder on America's Streets": Attacks Housing First, an evidence-based approach to ending people's homelessness by prioritizing their most essential need first—the need for housing.
- In 2023, Congress gave HUD the ability to make the FY24 CoC NOFO a 2-year competition, awarding the funding in FY24 and renewing it in FY25.
- On July 3, 2025 HUD sent a notice to CoCs and others that HUD intends to publish a NOFO for FY25. The NOFO still has not been released.

Public Housing

- Funding levels in the Senate bill are better than in the House, but still inadequate to maintain all existing Housing Choice Vouchers (about 100,000 in Illinois), renew all existing CoC projects at an adequate level, cuts funding for public housing and has no funding to maintain the Emergency Housing Voucher Program, which is currently assisting more than 1,800 Illinois households.
- In Illinois, it's estimate that the House version of the budget would reduce the the number of HCV recipients by 7,700 Illinois households and 17,200 people. The Senate budget would reduce HCV recipients in Illinois by 4,600 households and 10,200 people.

Issues in Different Housing Sectors

Fair Housing

- Much previously awarded and contracted fair housing funding to nonprofit organizations was terminated earlier this year, in February, by DOGE and subsequently restored, in March, through litigation.
- A July 26 court decision granted a Temporary Restraining Order in lawsuit against HUD for withholding fair housing funds that have not yet been awarded.
- A NOFO was subsequently released, with many differences from previous NOFO. The deadline to apply was August 21. No award announcements have been made yet.

Housing Counseling

 No issuance of FY25 Housing Counseling Program NOFO yet. The Trump administration budget zeroed ourt funding for this program for FY25.
 Thankfully, the Senate version provides flat funding.

Other Housing Policy Concerns (Partial List)

- In March, HUD announced that it is partnering with the Department of Homeland Security to help identify immigrants without legal status living in publicly subsidized housing. However, this announcement did not actually change any current law or policy immigration status eligibility to live in HUD assisted housing.
- July 2025 reintroduction of proposed changes to HUD mixed status household rule (similar or worse to what was proposed during first Trump administration).
 HUD sent notice of proposed rulemaking on July 16.
- July 2025 HUD notice of proposed rulemaking that seems to be focused on making easier for PHAs and others entities to impose time limits and work requirements.
- August 4 HUD notice of soon to be published final rule that is likely to roll back the Fair Housing Acts disparate impact standard. HUD did not provide any opportunity for comment on the rule. Disparate impact protections help remove unfair barriers that don't have a legitimate purpose and are discriminatory.

Members of Congress: Select Public Actions

 From Rep. Mike Quigley's press release after June 10, 2025 House THUD Appropriations Subcommittee hearing with HUD Secretary Scott Turner:

"Mr. Secretary, you have to understand: housing is everything. These people will die. There's no way you can believe a 50% cut won't put people on the street," said Quigley during the hearing. "What's the detailed plan to ensure those people won't be put on the street?"

Secretary Turner responded that his HUD would be "more effective and more efficient." However, when pressed by Quigley for details on how he would prevent homelessness, the Secretary provided none.
