## Final Federal CRA Rules Announced

For the first time in 28 years, on October 24, federal bank regulatory agencies jointly issued a <u>final rule</u> to significantly strengthen and modernize regulations implementing the Federal Community Reinvestment Act (CRA). As the co-convenor of the Illinois CRA Coalition, we are working with our partners to analyze and understand how to make use of the provisions that will most positively impact inequities in mortgage and small business lending.



The Illinois CRA Coalition is also reviewing and responding to state-level Illinois CRA rules; the Joint Committee on Administrative Rulemaking (JCAR) must take action on the proposed rules by December 16 for final implementation to take place.

# **Policy Focus**

### **Federal Government Shutdown Looming Again**

Congress has until November 17 to approve final spending bills or face another government shutdown. The road to enacting a final FY24 spending bill with sufficient HUD funding is steep. For example, neither the House nor Senate bill provides sufficient funding to renew all existing Housing Choice Vouchers. Under the Senate proposal, as many as 6,000 fewer households would receive needed assistance, and under the House funding level, roughly 40,000 fewer households would receive assistance. Housing Action is joining NLIHC in encouraging Illinoisans to contact legislators to urge them to expand—not cut—investments in affordable, accessible homes through the FY24 spending bill.

#### **Bring Chicago Home Referendum Gets on March Ballot**

On November 7, the <u>Bring Chicago Home</u> campaign passed a huge milestone: the Chicago City Council voted to put a referendum on the March 19 election ballot to create a new revenue stream legally dedicated to providing permanent affordable housing with wraparound supportive services to people experiencing homelessness. We encourage Chicago voters to vote **YES** on the question! As an endorser, we congratulate the Chicago Coalition for the Homeless and everyone else working on the campaign.

### **New Chief Homelessness Officer of Chicago Position Created**

Mayor Brandon Johnson recently <u>signed an executive order</u> to create a Chief Homelessness Officer of Chicago position, a senior role within the Mayor's Office. The goal of this position is to address homelessness in Chicago.

## What We're Sharing

Housing Action Policy Director Bob Palmer recently appeared on <u>WBEZ's Reset</u> to discuss Chicago's housing crisis, how Chicago's housing system has evolved over the years, and possible solutions.

IHC's application for host companies for the <u>Emerging Leaders Internship</u> (<u>ELI</u>) <u>program</u>, a 10-week paid internship whose goal is to increase racial and gender diversity in the affordable housing industry. Application deadline 11/17.

The Illinois Coalition for Fair Housing recently released a <u>Source of Income (SOI) self-advocacy toolkit</u> designed to help renters, homebuyers, and landlords understand the recent amendment to the Illinois Human Rights Act that designates source of income as a protected class.
